

## LEARNING TOGETHER PROGRAM



The Howard County Public School System includes Regional Early Childhood Centers (RECC) within nearly half of our local elementary schools. Our RECCs offer high quality early childhood programs that focus on developing kindergarten readiness skills for all children in classrooms that include children with and without disabilities.

## What is the Learning Together Program?

The RECCs provide special education services for preschoolers with disabilities in classes that also include children who do not have disabilities. This program enables all young children to play with each other, develop longterm friendships, and benefit from a diverse and stimulating environment. The purpose of the Learning Together Program is to include children who do not have disabilities in the RECC classes located within elementary schools.

The Learning Together Program will be accepting applications to attend one of our Regional Early Childhood Centers (RECCs) for the upcoming school year. Families of children who will be 3 by September 1 or 4 years of age may apply. Locations of RECC programs for the upcoming school year are budget-pending and will be confirmed prior to June 15th or the last day of the current school year. Locations with available LTP programs may vary each year.



A limited number of openings are available for children without disabilities. Children are selected based upon screening information given on the application form and space availability. If necessary, a lottery process is conducted. The fees listed in the application will be collected monthly regardless of the learning model determined by HCPSS throughout the upcoming school year (virtual, hybrid, or in person).

All completed applications MUST be submitted to the designated LTP Screening location based on your assigned home school. To confirm your child's home school based on your address, please visit the School Locator on hcpss.org.
